C I R C U L A R

Sub: Audit-High Level Committee Meetings - Observations of the
Commissioner of Municipal Administration and Chairman,
High Level Committee - Instructions issued.

During the High Level Committee Meeting held on 2.9.92, in the
presence of Commissioner of Municipal Administration, it was observed
that audit objections relating to non recovery of electricity charges
and house rent from Municipal Officers occupying Municipal quarters are
pending settlement for years together even after retirement of the
concerned officials.

It is also surprising to note that in certain Municipalities, the
electricity consumption charges are paid from Municipal funds initially
and later on demanded from occupying officers. As an occupier of
residential quarters, the electricity charges are payable only by
the occupants in their status as tenants. It is not also known why
the Municipality should pay the current consumption charges initially
from Municipal funds. If the charges are not cleared, the Electricity
Department may disconnect the service connection as in the case of
other consumers.

The Executive Authorities of Municipalities and Township Committees
are therefore directed that under no circumstance, the electricity
charges be paid by the Municipality.

In cases where the Electricity bills are received after the
Municipal Commissioners/other Officers occupying the Quarters vacate
the quarters due to transfer or otherwise, the bills should be sent to
concerned officers immediately for settlement of dues and the officer
concerned should ascertain the amount payable by him at the time of
vacating the Quarters.

All the Executive Authorities of Municipalities and Township
Committees are informed that the above instructions should be
strictly followed. Instances where the occupants do not clear
dues may be brought to the notice of this office.

The receipt of this Circular should be acknowledged by all at once.
