##### ACQUISITION OF LANDS

[G.O. Ms. No. 218, Transport (I-1), 9th September 2010.]

**No. II(2)/TRA/574(c-1)/2010.**

Whereas, in exercise of the powers conferred by clause (1) of Article 258 of the Constitution of India, the President of India has, in the Ministry of Food, Agriculture, Community Development and Co-operation (Department of Agriculture) Notification No. 4(1) / 65, General II, dated 23rd April 1966, entrusted to the Government of Tamil Nadu with their consent, the functions of the Central Government under the Land Acquisition Act, 1894 (Central Act 1 of 1894), in relation to acquisition of lands, for the purpose of the Union in this State.

And, whereas, the lands specified in the Schedule below and situated in Vadakkupoigainallur Village, Nagapattinam Taluk, Nagapattinam District, are needed for a public purpose, to wit, for the formation of New Broad Gauge Railway Line between Nagapattinam - Thiruthuraiipoondi Via Thirukkuvalai, notice to that effect is hereby given to all to whom it may concern, in accordance with the provisions of sub-section(1) of Section 4 of the Land Acquisition Act, 1894 (Central Act 1 of 1894).

And, whereas, it has become necessary to acquire immediate possession of the lands specified in the schedule below, the Governor of Tamil Nadu hereby directs that the lands be acquired under the provisions of sub-section (2) of Section 17 of the said Act.

Now, therefore, in exercise of the powers conferred by sub-section (2) of Section 4 of the said Act, the Governor of Tamil Nadu hereby authorises the Special Tahsildar (Land Acquisition), New Broad Gauge Railway Line Project, Nagapattinam and his staff and workmen to exercise the powers conferred by said sub-section and under clause (c) of Section 3 of the said Act, the Governor of Tamil Nadu, hereby appoints the Special Tahsildar (Land Acquisition), Nagapattinam New Broad Gauge Railway Line Project to perform the functions of the Collector under the said Act.

Under sub-section (4) of Section 17 of the said Act, the Governor of Tamil Nadu hereby directs that in view of the urgency of the case, the provisions of Section 5-A of the said Act shall not apply to this case.

And, whereas, it has already been decided that the compensation should be paid from the public revenue.
