Whereas, in the Notification issued with the S.O. first and second read above, this Commission directed that all the contesting candidates in the elections listed therein shall lodge a true copy of their accounts of election expenses kept by them or by their respective election agent under sub-rule (1) of Rule 116 of the Tamil Nadu Town Panchayats, Third Grade Municipalities, Municipalities and Corporations (Elections) Rules, 2006, in the format prescribed therefor under sub-rules (2) and (3) of Rule 116 of the said Rules with the officers mentioned therein, within thirty days from the date of declaration of the result of the elections;

2. Whereas, this Commission conducted casual elections to certain urban local bodies during October 2009 as notified in the SO third read above;

3. Whereas, the District Election Officer/District Collector, Tiruppur District, in his letter fourth read above reported that 7 candidates contested in the said casual elections for various offices failed to lodge copies of their account of election expenses as directed by this Commission;

4. Whereas, based on the report of the said District Election Officer/District Collector, a show cause notice was issued in the reference fifth read above to each of the contested candidate, who failed to lodge a true copy of the account of election expenses in the said election held during the month of October 2009, through the District Election Officer/District Collector, calling for explanation within 21 days of the receipt of the said notice, as to why action should not be taken against him as per sub-section (2-A) of Section 49 of the Tamil Nadu District Municipalities Act, 1920 (Tamil Nadu Act V of 1920);

5. Whereas, the said District Election Officer/District Collector in his letter sixth read above, has now reported that out of the said 7 contested candidates, 4 contested candidates lodged the account of election expenses and 3 contested candidates have neither submitted their explanations nor lodged the account of election expenses inspite of the show cause notices issued to them; and

6. Whereas, in view of the said report of the District Election Officer/District Collector, the Tamil Nadu State Election Commission is satisfied that 3 candidates listed in column (3) of the Table below against the contested election mentioned in the corresponding entry in column (2) thereof, have failed to lodge their account of election expenses as required by or under the said Act and have no good reason or justification for the failure.

7. Now, Therefore, in exercise of the powers conferred by sub-section (2-A) of Section 49 of the Tamil Nadu District Municipalities Act, 1920 (Tamil Nadu Act V of 1920), the Tamil Nadu State Election Commission hereby declares that the candidates listed in column (3) of the Table below against the contested election mentioned in the corresponding entry in column (2) thereof, shall be disqualified, for being elected as a President or Councillor or Ward Member in any election for a period of three years from the date of this Order.

Whereas, the said District Election Officer/District Collector in his letter sixth read above, has now reported that out of the said 35 contested candidates, 10 contested candidates lodged the account of election expenses and 25 contested candidates have neither submitted their explanations nor lodged the account of election expenses inspite of the show cause notices issued to them;

6. Whereas, out of the said 25 contested candidates 4 contested candidates who attend the enquiry on 13-8-2010 submitted the election expenses accounts in person with the Enquiry Officer; and

7. Whereas, in view of the said report of the District Election Officer/District Collector, the Tamil Nadu State Election Commission is satisfied that 21 candidates listed in column (3) of the Table below against the contested election mentioned in the corresponding entry in column (2) thereof, have failed to lodge their account of election expenses as required by or under the said Act and have no good reason or justification for the failure.
