No. II(2)/HWMP/171/2011.—The Governor of Tamil Nadu having been satisfied that the lands specified in the Schedule below are situated in 41 Punjai Lakkapuram, 45 Nanjai Uthukuli and 46 Pudur-A and B Villages have to be acquired for Public purpose to wit for the formation of Outer Ring Road for Erode Town and it having already been decided that the entire amount of compensation to be awarded for the lands is to be paid out of the funds, controlled or managed by the District Revenue Officer, Erode and having considered the cause shown by the owner or other persons having interest in the said lands, as the case may be do hereby publish the following notice under sub section (1) of Section 15 of the Tamil Nadu Highways Act, 2001 (Tamil Nadu Act 34 of 2002).
