CONSTITUTION OF SUB COURT AT VEDASANDUR IN DINDIGUL DISTRICT UNDER THE
TAMIL NADU CIVIL COURTS ACT.

In exercise of the powers conferred by the first paragraph of Section 4 of the Tamil Nadu Civil Courts Act, 1873 (Central Act III of 1873), the Governor of Tamil Nadu, hereby alters the number of Subordinate Judges to be appointed under the said Act for Dindigul District as **Five** with effect on and from the date on which the Subordinate Judge assumes charge of the Subordinate Judge's Court at Vendasandur.

In exercise of the powers conferred by Section 10 of the Tamil Nadu Civil Courts Act, 1873 (Central Act III of 1873), the Governor of Tamil Nadu, hereby directs that the Subordinate Judge's Court, Dindigul shall cease to have jurisdiction over the District Munsif-cum-Judicial Magistrate Court, Vendasandur and hereby fixes the local limits of the District Munsif-cum-Judicial Magistrate Court, Vendasandur as the local limits of jurisdiction of the Subordinate Judge's Court, Vendasandur with effect on and from the date on which the Subordinate Judge, assumes charge of the Subordinate Judge's Court, Vendasandur.
