It is hereby notified that the election to [i] THE SYNDICATE [ii] THE SENATE and [iii], THE STANDING COMMITTEE, OF THE ACADEMIC COUNCIL will be held under Section 18[a]-Other Members [2], Section 14(a) - Other Members [2] and Section 24 [k] of the Madras University Act, 1923.

**[i] To the Syndicate-Section 18[a]-Other Members [2]**

TWO MEMBERS to be elected by the Academic Council from among its members of one shall be teacher of affiliated colleges and one shall be a teacher of Approved Colleges.

The person getting elected will hold office as a member of the Syndicate for the residual period/full term (three years) from the date of receipt of nomination / the withdrawal / the period of present member term to be ceased / the date of election whichever is applicable for the election, as the case may be.

**[ii] To the Senate-section 14[a] - Other Members [2]**

TWO MEMBERS to be elected by the Academic Council from among its members.

**[iii] To the Standing Committee of the Academic Council [Section 24[k]]**

TWO MEMBERS viz., One Member shall be member of the Syndicate and One Member shall be the Principal or Teacher of Affiliated Colleges.

The newly elected members will hold office as a Member of the Standing Committee of the Academic Council for the residual period from the date of election / the date of withdrawal / the date of election / the date of declaration of results whichever is applicable for the election.

4. Nomination papers will be taken up for scrutiny at 4.45 p.m. on **09-11-2012**

5. List of valid nominations will be published at **5.30 p.m.** on **09-11-2012** in the University premises.

6. Notice of withdrawl of candidature may be made as per the General Statutes of the Tamil Nadu Dr. M.G.R. Medical University on or before **3.00. p.m.** on 16-11-2012.

7. List of final valid nominations will be published in the University premises at 5.30 p.m. on **16-11-2012**. A copy of Final valid nomination and the final list of voters will be despatched to the candidates.

8. A numbered declaration paper, a ballot paper, with the name of the candidates bearing on it, the Returning Officer's Initials, a cover for sending Ballot Paper and an envelope containing the address of the Returning Officer will be sent to the address entered against the name of the voter in the final electoral roll through the Heads of the Institutions/College in which he/she is working, on **22-11-2012** (Thursday). No ballot paper will be issued in the office to the voters on the day of election. The cover containing the ballot paper and the declaration from in the envelope be sent by Registered Post, so as to reach the Registrar In-Charge/Returning Officer not later than **4.00. p.m. on 07-12-2012**, the day fixed for poll.

9. The Voter may, either in person or by an agent, deposit the envelope addresses to the Returning Officer in the ballot box provided for the purpose at the office of the Returning Officer between **11.00 a.m. 4.00. p.m. on 17-12-2012 (Friday)**.

10. Scrutiny and counting of votes and declaration of results will be from **10.30 a.m. on 10-12-2012 (Monday)**, till the process is over.

**NOTE:**

1. The intimation of valid nominations would be sent to the candidates with a copy of the notification of the programme for the election containing last date of withdrawal and date of despatching the ballot paper to the Returning Officer by post, etc.

2. If the number of candidates, who are validly nominated and who have not withdrawn their candidates in the manner prescribed and within the time specified, does not exceed or is less than the number of vacancies to be filled, such candidate shall be declared to be duly elected.
