ACQUISITION OF LANDS

Whereas it appears to the Government of Tamil Nadu that the lands specified in the schedule below and situated in the Kuravarkulam village in Palayamkottai Taluk in Tirunelveli District are needed for a public purpose to wit for the formation of a Flood Carrier Channel by Interlinking Tamirabarani, Karumeniaru and Nambiyaru Rivers for the benefit of the dry areas in Tirunelveli and Tuticorin Districts. Notice to that effect is hereby given to all to whom it may concern in accordance with the provisions of the sub-section (1) of Section 4 of the Land Acquisition Act, 1894 (Central Act I of 1894).

And whereas it has become necessary to acquire immediate possession of the lands specified in the schedule below, the Governor of Tamil Nadu hereby directs that the lands be acquired under the provision of sub-section (1) of Section 17 of the said Act.

Now, therefore, in exercise of the powers conferred by the sub-section (2) of Section 4 of the said Act, the Governor of Tamil Nadu hereby authorizes the Special Tahsildar (Land Acquisition), Interlinking of Rivers Project – Unit III, Palayamkottai Taluk and his staff and workmen to exercise the powers conferred by the said sub-section.

Under sub-section (4) of Section 17 of the said Act, the Governor of Tamil Nadu hereby directs that in view of urgency of the case under clause (c) of Section 3 of the said Act, the provision of Section 5(A) of the said Act shall not apply to this case.
