No. SRO B-20/2013.—In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following amendment to the Special Rules for the Tamil Nadu Forest Service (Section 15 in Volume II of the Tamil Nadu Services Manual, 1969).

2. The amendments hereby made shall come into force on and from the 21-05-2013.

 - (ii) Tamil Nadu Forest Plantation Corporation Limited (upto 01-09-1992);
 - (iii) Arasu Rubber Corporation Limited; and
 - (iv) Outside the Forest Department on deputation".
