#### FINANCE DEPARTMENT

Ad hoc Rules relating to the Temporary Post of Additional Director of Treasuries and Accounts in the Tamil Nadu Treasuries and Accounts Department.

[G.O. Ms. No. 431, Finance (Treasuries and Accounts-I), 13th November 2013, Aippasi-27, Vijaya, Thiruvalluvar Aandu-2044.]

No. SRO B-49/2013.—In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following rules:-

2. The rules hereby made shall be deemed to have come into force on the 14th September 2010.

#### **RULES**

The General and Special Rules applicable to the holders of the permanent post of Joint Director of Treasuries and Accounts in the Tamil Nadu State Treasuries and Accounts Service shall apply to the holders of the temporary post of Additional Director of Treasuries and Accounts in the Tamil Nadu State Treasuries and Accounts Department, Subject to the modifications specified in the following rules:-

- 2. Constitution:— The post shall constitute a distinct class in the said service.
- 3. Appointment:— Appointment to the post shall be made by promotion from among the holders of the post of Joint Director of Treasuries and Accounts in the Tamil Nadu State Treasuries and Accounts Service.
  - 4. Appointing Authority:— The Government shall be the appointing authority for the post.
- 5. Qualifications:— No person shall be eligible for appointment to the post by promotion, unless he has completed service for a period of not less than five years in the post of Joint Director of Treasuries and Accounts.
- 6. Pay:— There shall be paid to the holders of the post, a monthly pay calculated in the Scale of Pay of (Pay Band 4) Rs. 37400-67000/- with Grade Pay of Rs. 8800/-

## PERSONNEL AND ADMINISTRATIVE REFORMS DEPARTMENT

#### Amendments to the Fundamental Rules.

[G.O. Ms. No. 138, Personnel and Administrative Reforms (FR.IV), 19th November 2013, கார்த்திகை 3, விஜய, திருவள்ளுவர் ஆண்டு—2044.]

No. SRO A-50/2013.—In exercise of the powers conferred by the proviso to Article 309 read with Article 313 of the Constitution of India and of all other powers hereunto enabling, the Governor of Tamil Nadu hereby makes the following amendments to the Fundamental Rules:-

2. The amendments hereby made shall be deemed to have come into force on the 16th May 2011.

#### AMENDMENTS.

In the said Fundamental Rules, in rule 101, under the heading, "Instructions under Rule 101(a) – Maternity Leave",-

- (1) in Instruction 1, for the expression "90 days" wherever it occurs, the expression "180 days" shall be substituted.
  - (2) in *Explanation* 2 under Instruction 1, for the expression "90 days", the expression "180 days" shall be substituted.

### Amendment to the Tamil Nadu Government Servants' Conduct Rules.

[G.O. Ms. No. 140, Personnel and Administrative Reforms (A), 21st November 2013, கார்த்திகை 5, விஜய, திருவள்ளுவர் ஆண்டு—2044.]

No. SRO B-51/2013.—In exercise of the powers conferred by the proviso to Article 309 of Constitution of India, the Governor of Tamil Nadu hereby makes the following amendment to the Tamil Nadu Government Servants' Conduct Rules, 1973.

#### AMENDMENT

In the said Rules, in rule 24-A, for the second proviso the following proviso shall be substituted, namely:-

"Provided further that the appointing authority concerned shall be competent to exercise the powers of the Government under this rule to issue No Objection Certificate to the Government Servants belonging to Group B, C and D who apply for grant or renewal of passport to visit foreign countries as tourists or on pilgrimage or to see friends or relatives or to seek employment".
