Ad hoc Rules relating to the Temporary Posts of Junior Assistant-cum-Typist and Stenographer in the Department of Environment.

[G.O. Ms. No. 197, Environment and Forests (EC.2), 9th December 2013 கார்த்திகை 23, விஜய, திருவள்ளுவர் ஆண்டு–2044.]

No. SRO B-54/2013.—In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following rules:-

- 2. The rules hereby made for the posts of-
- (i) Junior Assistant -cum- Typist shall be deemed to have come into force on the 17th September 1997; and
  - (ii) Stenographer shall deemed to have come into force on the 4th December 1996.

#### Rules

The General and Special Rules applicable to the holders of the permanent posts in Category 14 and 17 of the Tamil Nadu Ministerial Service shall respectively apply to the holders of the temporary posts of Junior Assistant-*cum*-Typist and Stenographer in the Department of Environment.

- **2. Constitution**:-The post shall each constitute temporary additions to the respective categories in the said service.
- **3. Appointing Authority**:-The appointing authority for the said posts shall be the Director, Department of Environment.
- **4. Pay**:-There shall be paid to the holders of the posts of Junior Assistant-*cum*-Typist and Stenographer, a monthly pay calculated in the scale of Rs.975-25-1150-30-1660 and Rs. 1200-30-1569-40-2040 respectively.
