No. 225/2012.—In exercise of the powers conferred by Section 13 of the Code of Criminal Procedure 1973 (Central Act 2 of 1974) the High Court hereby appoints the following 5 Deputy Tahsildars in Tiruvannamalai, 1 Tahsildar in Kancheepuram, 8 Tahsildars in Coimbatore District and 1 Deputy Tahsildar and 7 Tahsildar in Tiruvallur District to undergo Magistrial Training for a period of 120 days from the date of assumption of charge and confers upon them the ordinary powers conferrable under this Code on a Judicial Magistrate to try such cases which were earlier triable and dealt with by an erstwhile Judicial Second Class Magistrate.
