Now, Therefore, in exercise of the powers conferred by sub-clause (vi) of clause (n) of Section 2 of the said Act, the Governor of Tamil Nadu hereby declares the "Industries Manufacturing Boiler Auxiliaries for High Pressure Boilers" to be a public utility service for the purposes of the said Act for a period of six months from the date of publication of this notification in the *Tamil Nadu Government Gazette*.
