ORDER:

WHEREAS, in exercise of the powers conferred by sub-section (2-A) of Section 49 of the Tamil Nadu District Municipalities Act, 1920 (Tamil Nadu Act V of 1920), the Tamil Nadu State Election Commission in its Statutory Order second read above, had issued orders disqualifying 256 candidates of Sivagangai District for being elected as a Chairman or a Councillor or a Ward Member for a period of three years from the date of that Order for having failed to lodge their account of election expenses as required by or under the said Act;

2. WHEREAS, on receipt of accounts of remaining 25 candidates being lodged without explanation, it has been, *inter alia*, stated in para 8 of the aforesaid orders that further report with regard to said candidates had been called for from the District Election Officer, Sivagangai and the same report was called for by the Commission in its letters third read above; and

3. WHEREAS, the District Election Officer/District Collector, Sivagangai in his report fourth read above, has recommended that the accounts of election expenses and the explanations submitted by 25 candidates may be accepted.

NOW, THEREFORE, in view of the said report and recommendations of the District Election Officer / District Collector, the Tamil Nadu State Election Commission having satisfied with the report declares that the election expenses accounts and the explanation for the delay submitted by 25 candidates listed in column (3) of the Table below against the contested election mentioned in the corresponding entry in column (2) thereof, are hereby accepted by this Commission and further action in this regard is dropped.
