(a) The Vacation Civil Judge, who will be appointed by the Government for the District of Perambalur under Section 30 of the Tamil Nadu Civil Courts Act (Central Act III of 1873), as amended by Section 4 of the Tamil Nadu Act 17 of 1959, will attend the disposal of urgent civil work during Summer Vacation 2015, Civil Suits, Appeals and proceedings in Civil cases alone will be received and disposed off by him in terms of Section 30(c) of the above said Act and the rules.
