It is hereby notified that, according to Statute 5 of Chapter V of the laws of the University, Volume-I Calendar of the University, an election will be held for nominating a person by the Senate by the University to serve on the Committee of three, who are to suggest a panel of three names to the Chancellor for appointment of the Vice-Chancellor. The election will be held in accordance with the Statutes of Chapter V and the rules relating to the elections to the authorities of the University. Every nomination must be presented before the Registrar either by the proposer or the seconder or the person proposed before 3.00 p.m. on Thursday the 12th March, 2015.

The scrutiny of nomination will take place at 3.15 p.m. on Thursday the 12th March, 2015 at the Office of the Registrar, Madurai Kamaraj University, Madurai - 625 021. The proposer or the seconder or the proposed nominee can be present at the time of the scrutiny.
