

2. He started his career as Probationary Deputy Collector, Salem during 1982 and got conferment in the Indian Administrative Service on 29-03-2004. He held various posts in Government of Tamil Nadu which includes Revenue Divisional Officer, Mayiladuthurai, District Supply Officer, Dharmapuri, Deputy Secretary to Governor, Raj Bhavan, District Revenue Officer Pudukkottai, District Collector, Dindigul, Joint Transport Commissioner (Road Safety), Chennai, Joint Commissioner (Enforcement/Admin), Commercial Taxes, Joint Secretary (Protocol), Public Department, Joint Commissioner, Revenue Administration, Transport Commissioner, Director, ULC & UT, Managing Director, SIDCO, Inspector General, Registration and State Commissioner for the Welfare of Differently Abled, Chennai.

3. In the death of Thiru S. Murugaia, IAS, the Government of Tamil Nadu have lost one of its senior officers. The Government places on record its condolence to the bereaved family members.
