ORDER:

Based on the recommendation of the Third Tamil Nadu Pay Commission, the quantum of Advance for the purchase of Car, Motor Cycle, Scooter, Moped, etc have been enhanced in the Government order first cited. Now the Tamil Nadu Secretariat Association has requested that due to the Escalation in the cost of all the vehicles the quantum of advance may be revised taking into consideration the present day cost of vehicles.

2. The Government after careful consideration direct that in supersession of the orders issued in the Government order first read above the existing rules and conditions in the Tamil Nadu Financial Code Volume I, governing the sanction of advance for the purchase of conveyance be revised as indicated below:-

1.	Motor Car(New)	50,000 or cost of the vehicle whichever is less	100 monthly instalment.
2.	Motor Car (Second hand)	40,000 or the cost of the vehicle whichever is less.	85 monthly instalments
3.	Motor cycle(new)	6000 or cost of the vehicle whichever is less	69 monthly instalments
4.	Motor Cycle (second hand)	5000 or the cost of the vehicle whichever is less.	50 monthly instalments
5.	Scooter (New)	6000 or the cost of the vehicle whichever is less	60 monthly instalments.
6.	Scooter (Second hand)	5000 or the cost of the vehicle whichever is less	80 monthly instalments
7.	Mayuram Moped only(New)	3000 or the cost of the vehicle whichever is less	30 monthly instalments.
