## ORDER:

Based on the recommendation of the Third Tamil Nadu Pay Commission, the quantum of Advance for the purchase of Car, MotorCycle, Scooter, Moped, etc have been enhanced in the Government order first cited. Now the Tamil Nadu Secretariat Association has requested that due to the Escalation in the cost of all the vehicles the quantum of advane may be revised taking into consideration the present day cost of vehicles.

2. The Government after careful consideration direct that in super session of the orders issued in the Government order first read above the existing rules and conditions in the Tamil Nadu Financial Code Volume I, governing the sanction of advance for the purchase of conveyance be revised as indicated below:-

4. Mot Sycre 5000 or the cost of 50 monthly (second hand) the Tenicl which instalments ever is less.

5. Scooter (New) 6000 or the cost of the 60 monthly tehicle whichever is less instalments.

6. Scooter 5000 or the cost of the 80 monthly (Second hand) vehicle whichever is less instalments

7. Mayuram Moped 3000or the cost of the 30 monthly only(New) vehicle whichever is less instalments.

- 3. The Government servants mentioned in Article 230(A) and 231(a) of the Tamil Nadu Financial Code Volume I are eligible for the above advance.
- 4. Necessary amendment to Tamil Nadu Financial Code Volume I will be issued separately.
