I am directed to invite attention to your letter cited wherein clarifications on the following points have been sought for:-

- i) Whether the entire Dearness Allowance on 31-3-1978 based on the index price, 320 may be taken for calculation of House Rent Allowance and City Compensatory Allowance:
- ii) Whether the quantum of Dearness Allowance and interim relief of Rs.20/- drawn on 31-3-78 by the State Government employees appropriate to the pay drawn by the Central Government employees may alone be taken for calculation of HRA and CCA.
- iii) Whether the similar concession granted by the Central Government to State Government employees on deputation to Central on 1-1-1973 may be considered for fradation for the drawal of daily allowance.
- 2. The Government have carefully examined the matter and accordingly clarify the position as below:-
- i) According to 0.M.No.F.13016/2/81 EII(B) dated:25-3-82 issued by the Government of India, Ministry of Finance (Department of Expenditure), the Dearness Allowance sanctioned upto 320 points of the 12 monthly average of the All India Average Consumer Price Index for Industrial Workers as on 1-1-78 will be treated as pay for the purpose of payment of HRA and City Compensatory Allowance to the Central Government employees. The above order shall be applicable to the Central Government servants deputed to State Government autonomous bodies also. The entire Dearness Allowance sanctioned upto 320 points of the 12 monthly average of the All India Average Consumer Price Index shall be treated as pay for the purpose of payment of HRA and CCA. The same procedure may be adopted for sanction of daily allowance and travelling allowance. The Dearness Allowance merged pay (as on 1.1.1978) may be added to the basic pay plus deputation pay for fixing the grade of the officers for purposes of T.A. and D.A. The Travelling Allowance and Daily Allowance may be sanctioned on the basis of the merged pay ordered by the Government of India. The Government of India, is crediting the enhanced amount into General Provident Fund for the period from 1-2-1982 to 28-2-83 into Provident Fund Accout,

- ii) However, in regard to Travelling Allowance claims, I am to point out that according to Rule (2) under Rule 8 of the Tamil Nadu T.A. Rules, T.A. claims should be regulated by the rules in force at the time of the journey in respect of which the claims are made. Therefore the concessions In so far asit related to the T.A. claims, shall be with effect from the date of this letter.
