The following amendment is issued to G.O.Ms.  
No.815, Finance (Salaries) Department, dated 28.12.1982.

AMENDMENT

Substitute the following for the existing  
para 4 of the Government Order read above.

"4. After careful examination, the Government  
accept the request of the Accountant General  
and direct that in the cases of advances  
sanctioned to Non-Self Drawing Officers (i.e.)  
Officers on scale of pay the minimum of which  
is less than Rs. 1000/- and in whose case no  
payslip is issued by the Accountant General,  
the authorities competent to sanction conveyance  
advances are empowered to release the mortgage  
deed after satisfying themselves of the recovery  
of principal and interest without calling  
for "No Demand" Certificate from the  
Accountant General and after obtaining Under-  
taking from the Government Servants concerned  
for the recovery of the balance amount if any,  
from their pension and death-cum-retirement  
gratuity.
