



### Abstract

JBIC assisted Tamil Nadu Urban Infrastructure Project (TNUIP) – Under Ground Sewerage Scheme (UGSS) for Pattukottai Municipality at an Estimated Cost of Rs.33.90 crores – Administrative Sanction accorded- Orders – Issued

### ORDER:

In the G.O. read above, orders were issued according administrative sanction for implementation of the JBIC assisted TNUIP with a total project cost of Rs.344.70 crores. Accordingly, a sum of Rs.198.25 crores in the form of loan and a sum of Rs.84.98 crores as capital grant are proposed to be passed on to Urban Local Bodies. The Government have also constituted an Empowered Committee for sanctioning, finalizing the means of finance including the quantum of capital grants and according administrative sanction for the sub-projects to be funded under the JBIC assisted TNUIP.

2. The Pattukottai Municipality Council has resolved to take up the Under Ground Sewerage Scheme (UGSS). The Detailed Project Report (DPR) for the scheme has been prepared by TWAD Board at an estimated cost of Rs.33.90 crores and annual maintenance cost of Rs.47-20 lakhs. Tamil Nadu Urban Infrastructure Financial Services Limited (TNUIFSL) has analysed the financial viability for the scheme and has suggested the following pattern of funding:

3. The above proposal has been placed before the Empowered Committee constituted in the G.O read above for consideration on 18.9.2008 by the TNUIFSL. The Committee after careful examination, resolved to (i) approve



the proposal and recommend to the Government for according administrative sanction for implementation of Underground Sewerage Scheme for Pattukottai Municipality at an estimated project cost of Rs. 33.90 crores and at an estimated annual maintenance cost of Rs. 47.20 lakhs, (ii) sanction of Rs. 22.54 crores as capital grant and (iii) approve the following means of finance:

Based on the approval of the Empowered Committee, the Government have carefully examined the proposal and hereby, accord Administrative Sanction for implementation of UGSS in Pattukottai Municipality at an estimated cost of Rs.33.90 crores to install and Rs.47.20 lakhs to maintain annually as per the pattern of funding approved in para 3 above.

5. Any escalation in project cost, and O& M cost shall have to be borne by the concerned Municipality only.
