ORDER:

In the letter read above, the Director of Municipal Administration has stated that, in the G.O.(D)No.168, Municipal Administration and Water Supply Department, dated 23.9.2009, and the G.O.(2D)No:33, Municipal Administration and Water Supply Department, Dated:26.3.2009, among other urban local bodies, the Government has sanctioned and released 1st Instalment to the following urban local bodies:-

2. The Director of Municipal Administration has also stated that the Ministry Housing and urban poverty alleviation have sanctioned Additional Central assistance (ACA) of 50% of the 2nd installment under IHSDP scheme to the above said ULBs. The Government of India has indicated that out of the 50% balance (2nd installment) due for the ULBs, pending the submission of Third Party Inspection Monitoring Agency (TPIMA) report, 50% is being released now. The balance amount from Government of India would be released after submission Third Party Inspection Monitoring Agency's (TPIMA) Report.

3. The DMA has further stated that the Ministry of Finance, Department of Expenditure has released the total amount of Rs. 573.38 lakh as 2nd instalment (50%) to the above said urban local bodies for the year 2009-2010. The proportionate State Share along with the Central Share is detailed below:

The Director of Municipal Administration has therefore requested the Government to sanction & release the Cumulative Central & State share of Rs.713.515 lakhs (Gol share of Rs.573.381 lakhs + GOTN share of Rs.140.135 lakhs) to the above 4 ULBs as 2nd installment (50% release) for the year 2010 – 2011 under the Integrated Housing and Slum Development Programme (IHSDP) scheme and the balance amount 2nd installment (50% release) will be claimed from the Government on receipt of the Government of India releases for the above 4 ULBs.

5. The Government after careful examination, accept the proposal of the Director of Municipal Administration in para 4 above, and sanction and release the amount of Rs. 713.515 lakhs (Seven crores thirteen lakhs and fifty one thousand and five hundred only) as 2nd instalment to the 4 ULBs mentioned in para 3 above under IHSDP Scheme for the year 2010– 2011.

6. The amount sanctioned in para 5 above shall be debited for the following head of account.
