ORDER:

The Commissioner of Municipal Administration has stated that the Government had instructed that the expenditure under 13th Finance Commission, does not exceed 50% of the allotment within the period of six months from 1st April 2011. Accordingly, the 50% as 1st instalment for the third year 2012 -13, as follows:-
