In the 128th meeting of the Central Sanctioning and Monitoring Committee of the sub-mission on Basic Services to the Urban Poor (BSUP) of the Jawaharlal Nehru National Urban Renewal Mission (JNNURM) held on 13.03.2012, the committee approved the BSUP Avadi Phase − II Project, at a cost of Rs.1578.54 lakh for the construction of 500 Dwelling Units and infrastructure facilities in Avadi Municipality and the Government of India in their first read above have sanctioned and released a sum of Rs.197.32 lakh towards the 1st installment of Central Share for the above project.
