### ORDER:

While moving the demand for the Municipal Administration and Water Supply Department during the Budget Session 2012-2013, the Hon'ble Minister (MA&RD) has announced as below:-

In pursuance of the above announcement, the Commissioner of Municipal Administration in his letter read above has stated that as some of the Municipalities / Corporation are not financially sound enough he has proposed to allocate funds to the tune of Rs.26.00 crores from the (1) O&M Gap Filling Fund (Rs.21.00 crores) and (2) Infrastructure Gap Filling Fund (Rs. 5.00 Crores) for the year 2012-2013 and the balance fund to be met from the General funds of the Urban Local Body concerned as detailed below:-

- 3. In the circumstances, the Government after careful examination, accept the proposal of the Commissioner of Municipal Administration in para-2 above and to allocate Rs.21 crores from O&M Gap Filling Fund and Rs.5 Crores from Infrastructure Gap Filling Fund (total sum of Rs. 26.00 Crores) for the year 2012-2013 for construction of new office buildings and Rs.11.00 Crores from Urban Local Bodies contribution as indicated in the Table in paragraph 2 above.
- 4. The Government also to accord administrative sanction for Construction of Office Buildings in the Salem City Municipal Corporation at a cost of Rs.7.00 crores and in the Hosur Municipality at a cost of Rs.6.00 crores.

5. The amount sanction in para 4 above shall be debited under the following heads of account under Demand No. 34.02 as follows:-
