ORDER:

Based on the recommendations of the Third State Finance Commission, in the G.O. 1st read above, the Government have ordered that the 42% share of Urban Local Bodies, in the devolution grant should be distributed to Municipal Corporations, Municipalities and Town panchyats in the ratio 30:41:29 respectively and that the Government would set apart 3% towards infrastructure gap filling fund and 2% for Operational & Maintenance gap filling fund from the out of the share of each tier.

- 2. In the Budget Estimate 2012-2013 necessary provision has been made for the infrastructure gap filling fund and for the Operational and Maintenance gap filling fund for Municipal Corporations and Municipalities and the above allocations are to be distributed to the Urban Local Bodies, where fund is required for the creation/operational & maintenance of the needy infrastructure facilities.
- 3. The Common Committee called Infrastructure and O&M Gap Filling Fund Committee constituted in the G.O. 2nd read above, met on 07.09.2012 and accorded approval for the projects/schemes to be undertaken from out of the above funds provided in BE 2012-13.

4. Now, the Commissioner of Municipal Administration In the letter third read above, has requested the Government to sanction and release the amount allocated for the year 2012-13 under the Infrastructure and O&M gap filling fund as indicated below:-
