There is no corresponding State Share for this Government of India's release. The Chairman and Managing Director, TUFIDCO has certified that TUFIDCO has not received so far from the State Government.

The Government after careful examination accept the proposal of the Chairman and Managing Director, Tamil Nadu Urban Finance and Infrastructure Development Corporation Limited at para 2 above and accord sanction and release an amount of Rs.63,34,000/- (Rupees Sixty three lakhs thirty four thousand only) towards reimbursement of DPR cost for purchase of buses under stimulus packages for Chennai, Madurai and Coimbatore.
