### ORDER:

In the G.O. first read above, the Government have sanctioned the funds in the B.E. for the year 2012-13 towards the General Basic Grants under the 13<sup>th</sup> Central Finance Commission recommendation. It has also been instructed that the expenditure does not exceed 50% of the allotment within the period of six months from 1<sup>st</sup> April 2012.

2. In the G.O. second read above, the Government had released the 60% General Basic Grants as 1<sup>st</sup> installment for the third year 2012-13, as follows:-

3. In the letter 3<sup>rd</sup> read above, the Commissioner of Municipal Administration has stated that the above grants had been disbursed to the all Civic Bodies based on the 2001 census population and Utilization Certificate has already been sent to the Government.

4. Now, the Commissioner of Municipal Administration has requested the Government to sanction the balance General Basic Grant of **Rs.129,20,52,000/-** as 2<sup>nd</sup> installment and 100% General Performance Grant of **Rs.146,64,32,000/-** totaling a sum of **Rs.275,84,84,000/-** (Rupees Two hundred seventy five crore eighty four lakh and eighty four thousand only) for the third year 2012-13 as follows:-

The Government after careful examination accept the proposal of Commissioner of Municipal Administration at para 4 above and accord sanction and release an eligible amount of **Rs.86,13,69,345/-** (Rupees Eighty six crore thirteen lakh sixty nine thousand three hundred and forty five only ) towards the balance 40% of 2<sup>nd</sup> installment of General Basic Grant for the year 2012-13 under 13<sup>th</sup> Central Finance Commission.

6. The expenditure shall be debited under the following head of accounts:-

8. The Commissioner of Municipal Administration is authorized to draw the amount sanctioned in para 5 above and to disburse the grants to all the civic bodies.
