- 3. In the letter second read above, the Commissioner of Municipal Administration has requested the Government to issue orders for:-
- a) Sanction and release the cumulative amount Rs.2299.555 lakh (Rs.1966.41 lakh being GOI share and Rs.333.14 lakh being GOTN share) as 1st installment to the above said Municipalities and Corporations for the year 2012-2013 under Integrated Housing and Slum Development Programme (IHSDP) scheme.
- b) The other expenses proposed for Vellore Corporation, Hosur and Usilampatty Municipalities may be considered as ULB share.
- 4. The Government after careful examination accept the proposal of Commissioner of Municipal Administration at para 3 above and accord sanction and release a sum of Rs.22,99,55,500/- (Rupees Twenty two crore ninety nine lakh fifty five thousand and five hundred only) as 1st installment of GOI & GOTN share for the above mentioned projects under JNNURM IHSDP scheme for the year 2012 -13. "The other expenses" proposed for Vellore Corporation, Hosur and Usilampatti Municipalities will be considered as ULB share.
