ORDER:

In the Government Order fourth read above, the Government have accorded administrative sanction for the revised action plan of the Managing Director, Tamil Nadu Slum Clearance Board for a sum of Rs.297.88 crores

subject to the condition that the overall expenditure including construction cost shall not exceed Rs.250.00 crores recommended by XII Finance Commission as approved by the High Level Committee.

2. In the letter twelfth read above, orders were issued approving the revised completion plan of the Managing Director, Tamil Nadu Slum Clearance Board.

3. The Managing Director, Tamil Nadu Slum Clearance Board, in his letter thirteenth read above, has requested the Government to release the balance amount of Rs.11.51 crore in respect of the following schemes:-
