ORDER:

The Managing Director, Tamil Nadu Slum Clearance Board, in his letter read above has stated that a sum of Rs.10.00 crores has been allocated as budgetary support for the year 2011-12 for Environmental Improvement of Urban Slums schemes for providing basic amenities to the Urban Slums in Tamil Nadu and that as part of this programme, Tamil Nadu Slum Clearance Board has proposed to provide basic amenities in Thiruvallur, Kancheepuram, Dindigul, Madurai, Ramanathapuram, Theni, Trichy, Karur, Perambalur, Thiruvarur, Thanjavur, Pudukottai, Coimbatore, Erode, Tiruppur, Salem, Namakkal, Kanyakumari, Thoothukudi, Virudhunagar and Tirunelveli districts covering 89 slums for Rs.674.20 lakhs. The Board vide in its Resolution No.4.07/446, dated 15.02.2012 has approved the above proposal of the Managing Director, Tamil Nadu Slum Clearance Board.

- 2. The Managing Director, Tamil Nadu Slum Clearance Board has therefore requested the Government to release a sum of Rs.674.20 lakhs from the budgetary support of Rs.10.00 crores provided under Environmental Improvement of Urban Slums for the year 2011-12 for implementation of 89 Environmental Improvement of Urban Slums Scheme.
- 3. The Government after careful examination, accept the proposal of the Managing Director, Tamil Nadu Slum Clearance Board, and accord sanction for release of Rs.674.20 lakhs (Rupees Six hundred seventy four lakhs and twenty thousands only) to implement the development works of 89 slums to benefit 17315 families in various Districts of Tamil Nadu under Environmental Improvement of Urban Slums.

- 4. The expenditure sanctioned in paragraph 3 above shall be debited to the following Head of account.
 - "2217-Urban Development-04-Slum Area Improvement 190-Assistance to Public Sector and other undertakings I-Non-plan AF-Grants to Tamil Nadu Slum Clearance Board for improving basic amenities in slums-09-Grants-in-Aid-01. Grants for Current Expenditure" (DP Code 2217 04 190 AF 0911)".
- 5. The amount sanctioned in paragraph 4 above shall not be paid in cash but credited to the following Head of account. "K Deposits and Advances (b) Deposits not bearing Interest–8443-00 Civil Deposits 800 other Deposits CA Deposits of Tamil Nadu Slum Clearance Board (DP Code No.8443-10-800-CA-000J (Receipts).
- 6. The Director of Treasuries and Accounts, Chennai-15, is authorized to draw the amount sanctioned in para 3 above and disburse the same by means of an Account Payee cheque in favour of Personal Deposit Account of Tamil Nadu Slum Clearance Board so as to enable the Slum Clearance Board to remit the same in the State Bank of India, Thousands light Branch, Chennai.
- 7. The Managing Director, Tamil Nadu Slum Clearance Board is requested to take necessary action to implement the above scheme after following the procedures in force and send a report to the Government along with an expenditure statement in due course.
- 8. This order issues with the concurrence of Finance Department vide its U.O.No.108/JS (PM) dated 29.03.2012.
