#### ORDER:

In the G.O. first read above, the Government had released the 3<sup>rd</sup> installment of GOI and GOTN share of Rs.406.24 lakh and in the G.O. second read above, the Government had also released 4<sup>th</sup> installment of GOI share of Rs.212.21 lakh to Kurichi, Kuniamuthur and Goundampalayam Municipalities under JNNURM – BSUP scheme.

2. In the G.O. third read above, the Government released a sum of Rs.339.25 lakh towards  $4^{\rm th}$  installment of State share under JNNURM - BSUP scheme to 7 Municipalities and deferred the release of Rs.189.21 lakh to 3 Municipalities (ie, Kurichi, Kuniamuthur and Goundampalayam) as the  $3^{\rm rd}$ 

installment has not been released by the Commissioner of Municipal Administration for these 3 Municipalities.

- 3. In the letter fourth read above, the Commissioner of Municipal Administration, has requested the Government to release the 4<sup>th</sup> installment of State share to the Kurichi, Kuniamuthur and Goundampalayam Municipalities, in order to expedite the work at the earliest.
- 4. The Government after careful consideration accepts the proposal of Commissioner of Municipal Administration and release an amount of Rs.189.21 lakh (One crore Eighty nine lakhs and Twenty one thousand only) as 4<sup>th</sup> instalment state share to Kurichi, Kuniamuthur and Goundampalayam Municipalities as detailed below.
