3. Now, the Commissioner of Municipal Administration has requested the Government to release the above amount of Rs.79,91,601 for the above ULBs under USHA scheme for the year 2012-13.

The Government after careful examination accept the proposal of the Commissioner of Municipal Administration at para 3 above and accord sanction and release an amount of Rs.79,91,601/-(Rupees Seventy Nine lakh ninety one thousand six hundred and one only) for the above ULBs (listed in para 1& 2 above) under USHA scheme for the year 2012 -13.

Pending provision of funds in FMA 2012-2013, The Commissioner of Municipal Administration is authorized to draw and disburse the amount through IHSDP Saving Bank Account No. 30120518397 maintained in State Bank of India, PWD Complex, Chepauk, Chennai -5 .
