#### ORDER:

During the Collector's Conference held on 13.11.2011, the Hon'ble Chief Minister made an announcement to the effect that "An Integrated Bus Stand will be set up in Thoothukudi".

2. Following the announcement, the District Collector in his letter dated: 05-12-2011 suggested that the New Integrated Bus Stand may be constructed at Meelavittan Revenue village of Thoothukkudi Taluk opposite to Thoothukkudi Fisheries College.

3. Meanwhile, objections to construction of the bus stand at the site proposed by the District Collector have been received from various quarters.

4. In this regard, the Commissioner of Municipal Administration in his letter, dated: 07-11-2012 has stated as follows:-

- ❖ As per the District Collector's report the bus stands which are functioning now are inadequate.
- ❖ Some sections of the public have objected to the site proposed by the District Collector to locate the New Integrated Bus Stand.
- ❖ The Council of the Thoothukkudi City Municipal Corporation has proposed to expand the existing old bus stand by acquiring the adjacent Bus Depot (2.00 acres) and SAV School Ground (3.50 acres). The existing old bus stand (1.50 acres) can be expanded to approximately 7.00 acres.

The Commissioner of Municipal Administration has suggested that in view of the different views taken by the Thoothukkudi City Municipal Corporation, District Collector, a feasibility study may be conducted by the consultant on the proposed sites for construction of the New Integrated Bus Stand in Thoothukkudi.
