ORDER:-

In G.O.(Ms).No.45, Municipal Administration and Water Supply Department, Dated.3.3.92 the Government accorded sanction for an outlay of Rs.114.72 lakhs (Rupees One hundred and fourteen lakhs and Seventy two thousand only) to the Municipalities of Arakkonam, Sengottai and Kadayanallur Municipalities under Municipal Urban Development Fund.

2. Now the Secretary, Project Management Group has forwarded the Empowered Committee note recommending sanction of projects for Sirkazhi and Chidambaram Municipalities.

3. Sanction is hereby accorded under rule VII of the Tamilnadu Municipal Urban Development Fund Rules, 1988 for taking up the following projects in Sirkazhi and Chidambaram Municipalities at an outlay of Rs.319.80 lakhs (Rupees three hundred and Nineteen lakhs and Eighty thousand only) under Municipal Urban Development Fund.
