ORDER:

In the Government Order first read above, orders were issued appointing Dr. P. Kanagasabapathi as Director, Tamil Nadu Institute of Urban Studies, Coimbatore on contract basis for a period of three years from the date of assumption of charge in the post. In the Government Order second read above, orders were issued extending the tenure of Dr. P. Kanagasabapathi for two more years from 22.01.2010. In the Government Order third read above, the Government permitted the extension of the contract appointment of Dr. P. Kanagasabapathi, Director, Tamil Nadu Institute of Urban Studies, Coimbatore for a further period of 3 months with effect from 22.01.2012 (i.e., till 21.04.2012) and also accorded permission to initiate action for the selection of a new candidate by following the procedure prescribed in the Regulations of the Tamil Nadu Urban Studies, Coimbatore.

2. In the Government Order fourth read above, Thiru B. Balachandran, Regional Director of Municipal Administration, Tiruppur was directed to take over additional charge of the post of Director, Tamil Nadu Institute of Urban Studies, Coimbatore and hold the post till a new candidate is appointed as Director, Tamil Nadu Institute of Urban Studies, Coimbatore.

3. In the Government Order fifth read above, Thiru B. Balachandran, Regional Director of Municipal Administration, Tiruppur, who was holding additional charge of the post of Director, Tamil Nadu Institute of Urban Studies is placed under suspension with effect from 22.10.2012.

4. In the letter sixth read above, the Commissioner of Municipal Administration has stated that a new candidate has not yet been selected for the post of Director, Tamil Nadu Institute of Urban Studies by the Search Committee and the officer who held additional charge of the said post is placed under suspension and hence another officer has to be directed to hold additional charge of the post of Director, Tamil Nadu Institute of Urban Studies. He has requested the Government that Thiru Ajay Yadav, I.A.S., Joint Commissioner of Municipal Administration, may be placed additional charge of the post of Director, Tamil Nadu Institute of Urban Studies till a new candidate is appointed as Director.

5. The Government have examined the proposal of the Commissioner of Municipal Administration carefully and decided to accept it. Accordingly, Thiru Ajay Yadav, I.A.S., Joint Commissioner of Municipal Administration is placed additional charge of the post of Director, Tamil Nadu Institute of Urban Studies, Coimbatore immediately until further orders.
