ORDER:

With a view to impart training to Municipal Commissioners and employees of Municipalities, and Municipal Corporations for achieving greater efficiency in the functioning of civic Administration, Orders were issued in the G.O. first read above for establishment of the Tamil Nadu Institute of Urban Studies at Coimbatore. The Urban Local Bodies were permitted to remit annual contribution to run the administration of the said institute. In the Government Order second read above, the rates of annual contribution has been revised as follows in accordance with the grades of the Urban Local Bodies with effect from the year 1987-88:-

2. The Director, Tamil Nadu Institute of Urban Studies Coimbatore has stated that five years have passed since fixation of rates of contribution as stated above. Subsequent to this, the pay and allowances of the officers and staff have been revised upward based on the V Tamil Nadu Pay Commission Report. Dearness Allowance has also been increased eight times since then. The cost of stationery articles and day-to-day maintenance expenditure have also increased considerably. Further, the Management Committee of the Institute resolved to appoint two additional faculty members in the Disciplines of Engineering and Public Health in the time scale of Pay of Rs.3000-4500 for widening the scope of activities of the Institute with a view to provide better service to the urban local bodies and this would involve additional expenditure to the tune of Rs.3,00,000/- per annum. The Management Committee of the Institute in its resolution No.24, dated 5.3.92 has therefore resolved to approach the Government to increase the rate of contribution from the year 1992-93 onwards as detailed below:-

The Director has also stated that if the rates of contribution are raised as requested above, the Institute can anticipate an annual revenue of Rs.25,00,000/- and thereby balance the increasing day-to-day expenditure and the expenditure required for future programmes including additional construction of office building and hostel building. He has further stated that the financial capacity of the urban local bodies has already increased over 100% after the last quinquennial revision of taxes from 1.10.87. In addition, there has been annual increase in its income for the past 5 years, to about 30% to 35%. Therefore, the overall income position of the urban local bodies has increased in the last 5 years nearly two times and they are in a position to pay the revised rates of contribution proposed by the Management Committee.

3. The Director of Municipal Administration has stated that, considering the financial difficulties of the Institute, the Annual Contribution paid by the local bodies may be increased as requested by the Director of the Institute except to Third Grade and Second Grade Municipalities, as the financial position of these Municipalities are not satisfactory. He has also stated that the status quo may be maintained in respect

of Second Grade and Third Grade Municipalities.

4. The Government after careful consideration accept the recommendation of the Commissioner of Municipal Administration and direct that the Tamil Nadu Institute of Urban Studies, Coimbatore shall receive an annual contribution from the Urban local bodies at the revised rates indicated in column(3) of the statement below from the financial year 1995-96.

So far as the 2nd and 3rd Grade Municipalities are concerned, the Institute shall continue to receive the annual contribution at the existing rates viz. Rs.4,000/- and Rs.2,000/- respectively.

5. The Government permit each of the Municipalities, and Municipal Corporations to remit the contribution at the rates mentioned above from their General Fund.
