APPENDIX  
NOTIFICATION

In exercise of the powers conferred by sub-section (1) of Section 375 of the Tamil Nadu District Municipalities Act 1920 (Tamil Nadu Act V of 1920) as amended by the Tamil Nadu District Municipalities (Amendment) Act 1994 (Tamil Nadu Act 25 of 1994), and in modification of the Notifications issued earlier by the Government appointing Special Officers to all the Municipalities in the State, the Governor of Tamil Nadu hereby appoints the District Collectors as Special Officers of all the Municipalities in their respective Districts to exercise the powers and discharge the functions of the respective Municipalities for the period upto the 31st day of December 1996 or for such shorter period as the Government may by notification specify in this behalf.

NOTIFICATION - II

In exercise of the powers conferred by sub-section (1) of Section 10 of Tirunelveli City Municipal Corporation Act, 1994 (Tamil Nadu Act 28 of 1994), the Governor of Tamil Nadu hereby appoints the District Collector, Tirunelveli as Special Officer to exercise the powers and discharge the functions of the Corporation of Tirunelveli for the period upto the 31st day of December 1996 or for such shorter period as the Government may by Notification, specify in this behalf.

NOTIFICATION - III

In exercise of the powers conferred by sub-section (1) of Section 10 of the Salem City Municipal Corporation Act, 1994 (Tamil Nadu Act 29 of 1994), the Governor of Tamil Nadu hereby appoints the District Collector, Salem as Special Officer to exercise the powers and discharge the functions of the Corporation of Salem for the period upto the 31st day of December 1996 or for such shorter period as the Government may by Notification, specify in this behalf.
