APPENDIX NOTIFICATION

In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following amendment to the Special Rules for the Tamil Nadu Municipal Commissioners' Subordinate Service (Section 23B in Volume III of the Tamil Nadu Services Manual, 1970).

2. The amendment hereby made shall be deemed to have come into force on the 29th January 1985.

AMENDMENT

In the said Special Rules, after rule 6, the following rule shall be added, namely:-

"7- Training.- Every person appointed to the service by direct recruitment from open competition shall undergo an intensive induction training for a period of twelve weeks as specified below and the period of training shall be counted both for probation and increment
