APPENDIX

AMENDMENT.

In exercise of the powers conferred by sub-section (2) of section 77-A of the Tamil Nadu District Municipalities Act, 1920 (Tamil Nadu Act V of 1920); the Governor of Tamil Nadu hereby makes the following amendments to the Special Rules for the Tamil Nadu Municipal General Service Rules, 1970.

AMENDMENTS.

In the said Special Rules,-

(1) in rule 1,-

- (i) in Class VII, after Category 4, the following Category shall be added, namely:-
"Category 5 ----- Revenue Assistant, Grade I";
- (ii) the expression "Class VII-C Selection Grade Bill Collectors" shall be omitted;
- (iii) in Class IX, for the expression "Category 2 ----- Bill - Collector", the expression "Category 2 -----Revenue Assistant Grade-II" shall be substituted;

(2) in rule 3:-

- (i) in sub-rule (b), in the Table, the expression "Class VII-C Selection Grade Bill Collector" in column (1) and the entry relating thereto in column (2) including the proviso thereunder shall be omitted;

(ii) in sub-rule (c)-

(I) in the Table under clause (i) :-

(a) In Class VII, for the Categories in column (1) and the entry relating thereto in column (2), the following categories and entry shall, respectively, be substituted, namely:-

Category 1	Junior Assistant	
Category 2	Poor House Warden	
Category 3	Shroff	By direct recruitment or by promotion from the Category of Record Clerk and Revenue Assistant, Grade II.;
Category 4	Store-Keeper, Grade II	
Category 5	Revenue Assistant, Grade I	

(b) in Class VII A, for the entry in column (2) against the Category "Typist including Steno-Typist" in column (1), the following entry shall be substituted, namely:-

"By direct recruitment or by promotion from the Category of Revenue Assistant, Grade II and Record Clerk.;"

(c) for the expression "Class IX-Category 2 Bill Collector" in column (1) and the entry relating thereto in column (2), the following Category and the entry shall, respectively, be substituted, namely:-

"Class IX category 2 Revenue Assistant, Grade II By direct recruitment or by recruitment by transfer from the Last Grade Service.;"

(d) for the entry in column (2), against the expression "Class X Category 1 Record Clerk" in column (1), the following entry shall be substituted, namely:-

"By direct recruitment or by recruitment by transfer from the Last Grade Service.;"

(II) for clause (ii), the following clause shall be substituted, namely:-

(ii) Appointment by direct recruitment and by promotion to Class VII shall be made in the ratio of 2:1 and appointment by direct recruitment and by recruitment by transfer to Category 2 of Class IX and Category 1 of Class X shall be made in the ratio of 3:1. If sufficient number of candidates are not available for promotion or by recruitment by transfer, the vacancies shall be filled by direct recruitment";

(3) In rule 5, in sub-rule (a), for the proviso, excluding the explanation, the following proviso shall be substituted, namely:-

"Provided that a person, who has completed S.S.L.C. shall be appointed by direct recruitment to category 2 of Class IX and Category 1 of Class X and a person who has passed VIII standard in a recognised School shall be appointed by recruitment by transfer to Category 2 of Class IX and category 1 of Class X";

(4) In rule 6,-

- (i) for the expression "28 years", the expression "thirty years" shall be substituted;
- (ii) in the proviso, for the expression "23 years", the expression "thirty-five years" shall be substituted.
