NOTIFICATION

In exercise of the powers conferred by sub-section (2) of section 8 the Tamil Nadu Public Health Act, 1939 (Tamil Nadu Act III of 1939), the vernor of Tamil Nadu hereby makes the following amendment to the Tamil du Municipal Public Health Service Regulations, 1970.

2. The amendment hereby made shall come into force with effect and from the sixteenth day of November, 2006

the said Regulations, in regulation 3, for clause (i), the following clause shall substituted namely:-

- "(i) Authority competent to recruit candidate and to make appointments.
- (a) The authority competent to recruit in respect of the class and categories specified in Column (1) in the table below shall be the authority specified in column (2) thereof:-

Class II and Category 1 of Class IV	The selection committee
Class I and III, and Category 2 of Class IV and Class V	The appointment committee

(b) The procedure prescribed in clause (i) of rule 9 of the Special Rules or the Tamil Nadu Municipal General Service Rules, 1970 contained in Section I Part III shall be followed by the Selection Committee in the matter of scruitment by promotion and by recruitment by transfer. The procedure rescribed in clause (ii) of the said Rule, shall be followed by the appointment ommittee in the matter of direct recruitment.

(c) The authority competent to appoint in respect of the Classes and categories specified in column (1) of the table below shall be the authority specified in column (2) thereof:-

NOTIFICATION

In exercise of the powers conferred by sub-section (2) of section 8 of Tamil Nadu Public Health Act, 1939 (Tamil Nadu Act III of 1939), the ernor of Tamil Nadu hereby makes the following amendment to the Tamil of Municipal (Non-Centralised-Regular) Public Health Establishment gulations, 1976.

2. The amendments hereby made shall come into force with effect and from the sixteenth day of November, 2006.

<u>AMENDMENT</u>

In the said Regulations, for regulation 6, the following regulation shall be substituted, namely:-

- "8. Authority competent to recruit candidates and to make appointments.-
- (a) The authority competent to recruit in respect of all categories of posts shall be the appointment committee;
- (b) The Appointing authority competent to appoint in respect of all categories of posts shall be the Commissioner of the Municipality:
- (c) The appointment committee shall follow the procedure prescribed in clause (ii) of rule 9 of the Tamil Nadu Municipal General Service Rules, 1970 contained in Section 1 of Part III Special Rules of the Tamil Nadu Municipal General Service Rules, 1970 in the matter of recruitment by direct recruitment and the procedure prescribed in clause (iii) of the said Rule shall be followed in the matter of recruitment by promotion and recruitment by transfer".
