

APPENDIX

NOTIFICATION

In exercise of the powers conferred by sub-section(2) of section 77-A of the Tamil Nadu District Municipalities Act, 1920 (Tamil Nadu Act V of 1920), the Governor of Tamil Nadu hereby makes the following amendments to the Tamil Nadu Municipal Engineering Subordinate Service Rules, 1970 (in Part-III Special Rules - Section 2 of the Tamil Nadu Municipal Service Rules, 1970).

AMENDMENTS

In the said Rules:-

1. In rule 3, in sub-rule (b) :-

(a) in the table, (i) in column (2), against the entry "9. Category 4 of Class V" in column (1) thereof, for the expression "Categories 1 and 2 of Class VII-A", the expression "Category 2 of Class VII-A and Category 8 of Class VIII" shall be substituted;

(ii) after the entry "13. Category 2 of Class VII-A" in column (1) and the corresponding entry in column (2) thereof, the entries "14. Category 8 of Class VIII" in column (1) and "Category 9 of Class VIII" in column (2) shall be added respectively.

(b) after the existing proviso the following proviso shall be added, namely:-

"Provided further that the promotion to the post of Electrician Grade-I from the feeder categories of Wireman and Electrician Grade-II shall be made in the ratio of 2:1."

2. In rule 4:-

(a) in sub-rule (a), in column(1):-

(i) after the expression "Class IV", the expression "Category 4 of Class V" shall be added;

(ii) for the expression "Class IV", the expression "Categories 1, 2, and 3 of Class V" shall be substituted;

(b) in sub-rule (b), in column (1):-

(i) after the expression "Class IV", the expression "Category 4 of Class V" shall be added;

(ii) for the expression "Class V" the expression "Categories 1, 2, and 3 of Class V" shall be substituted.

3. In rule 6, in the Table, under class VIII column (2), against the entry "Category 9 in column (1) thereof, after the expression "A pass in the VIII Standard" the following proviso shall be added, namely:-

"Provided that wherever the candidates prescribed with technical qualifications but not having experience prescribed in the rules are available in view of the long experience of the individuals, the Tamil Nadu Institute of Urban Studies, Coimbatore shall conduct a short term training course on the subject, the syllabus of which shall include hand-on experience in the nearby Corporation or Municipality and a certificate awarded after suitable test to the participants. This certificate shall be admitted in such cases of individuals as equivalent for practical experience prescribed for the post of Electrician Grade-I and Grade-II".
