ORDER:

The Chairman, Tamil Nadu Housing Board has sent a proposal to exempt the Tamil Nadu Housing Board from the payment of property tax to the local bodies in respect of the slum tenements constructed by the Board in the mofussil areas.

2. In the G.O. First read above the Government decided that the Tamil Nadu Slum Clearance Board should pay to the Corporation of Madras, the property tax including arrears of previous years, in respect of its completed tenements and that the amount so far paid by the Tamil Nadu Slum Clearance Board be reimbursed to it by Government by way of half yearly grants.

3. The Government are sanctioning to the Tamil Nadu Housing Board a grant of Rs. 10/- lakhs every year which represents the difference between the subsidised rent fixed by the Government and the economic rent fixed by the Board. The Tamil Nadu Housing Board is also paying the property tax to the local bodies concerned in respect of the slum tenements from out of this Government grant sanctioned every year.

4. In view of the above position the question of reimbursing the property tax to the Tamil Nadu Housing Board by way of Half Yearly grant on the analogy of the orders issued in G.O. Ms.No. 876, Housing and Urban Development, dated 3.7.87 as in the case of Tamil Nadu Clearance Board does not arise.

5. In the context of the orders issued in the G.O. mentioned in para 4 above the Government do not accept the proposal of the Chairman, Tamil Nadu Housing Board to grant exemption of the Board from payment of property tax to the Slum tenements in unfussil areas.
