ORDER

The Government sanction the payment of a sum of  
Rs. 20,33,328.50/- (Rupees twenty lakhs thirty three  
thousand three hundred and twenty eight and paise fifty only)  
as toll compensation due to the local bodies for 1985-86.  
The amounts due to the Local Bodies are payable in  
one lumpsum.

2. The sum of Rs. 20,33,328.50/- will be distributed  
among the local bodies (including the contonment authorities  
in Tamil Nadu), as shown in the appended statement,

3. The expenditure will be debited to "363  
Compensation and Assignments to Local Bodies and Panchayat  
Institutions - A. Compensation and Assignments  
to Local Bodies and Panchayat Rai Institutions - AC,  
Taxes on vehicles - I. Non-Plan-AB. Compensation for loss  
of income from Tolls and Taxation of Motor Vehicles -  
charged (D.P. Code No. 363 A ACAB 0009). It will be met from  
existing budget provision of Rs. 20,33,000/-

4. The Accountant-General, Madras is requested  
to arrange for the payment referred to in paragraph 2  
above and send a report to the Government when the payments  
have been made.
