ORDER:

The Examiner of Local Fund Accounts, in his letter read above, has pointed out that certain Municipal Commissioners have not paid the rent for occupation of Municipal quarters. He has therefore requested the Government to issue suitable instructions regarding payment of rent by the Municipal Commissioners. He has also made the following suggestions:-

- (a) The Commissioners occupying the Municipal quarters should be asked to shift their family within a month after transfer to a new station;
- (b) Recovery of telephone charges from the Commissioners whose family continue to occupy the quarters at the old station;
- (c) Withdrawal of G.O.Ms.No.2192, R.D.&L.A., dt. 10.10.1974 granting exemption to occupation of quarters to those who own houses in the place of posting.

2. The Government have carefully examined all the suggestions made by the Examiner of Local Fund Accounts and issue the following instructions:-

- (1) The Municipal Commissioners occupying the Municipal quarters should shift their family to the new station on transfer as quickly as possible and to remit the rent to the old station in case his family is continued in the quarters at the old station till they shift the family to the new station;
- (2) The Municipal Commissioners should address their counterparts for the remittance of rent in case families are continued in the old station and in case of continued default the same should be brought to the notice of Director of Municipal Administration for appropriate action;

- (3) As regards the withdrawal of G.O.Ms. No. 2192, R.D.&L.A., dated 10.10.1974, the Government consider that no change need be made to the instructions already issued. The status-quo may continue.

3. The Executive Authorities of Municipalities and Municipal Township Committees are directed to follow the above instructions scrupulously. They are also informed that failure to follow the above instructions will be viewed seriously.
