LICENCE - Taking out licence for storing cinematograph films under Tamil Nadt District Municipalities Act, 1920 - Orders - Cancelled

Director of Fire Services and erstwhile Board of Revenue expressed the view that cinemotograph film is combustible and slow burning. The Government accepted the above views and in the G.O. first read above, issued orders that for storing cinematograph films, a licence should be taken under Section 249 of Tamil Nadu District Municipalities Act, 1920, as it attracts clause (q) of Schedule V of the Act.

- 2. But the Hindustan Photo Filmscertified that the films are not one of explosive or inflammable nature. The Board of Revenue also revised its earlier views and observed in December '78 that in the Tamil Nadu Cinemas (Regulation) Rules there is a specific provision for storing cinema films upto 200 lbs. in the licenced premises and that the present day cinematograph films are coated on acceptages at the storing of films at has in the circumstances stated that the storing of films at Ginema theatres would not attract the provisions of Tamil Nadu District Municipalities Act, 1920. The Board held that the orders issued in the G.O.first read above, would have to be withdrawn.
- 3. Moreover, in a case filed before a Judicial Magistrate, the Court accepted the avide nce and the contention that the Modern films are not combustible and that no licence need be taken under the Tamil Nadu District Municipalities Act, 1920. The Examiner of Local Fund Accounts in also suggested that the orders issued in the G.O.first read above, be reexamined in the light of the above judgement keeping both the legal aspect and the revenue aspect. In view of the certificate that modern films manufactured

the recommendation that the orders issued in the G.O. first read above, can be cancelled.

4. The Government accept the above recommend tions and dire that the orders issued in the G.O.first read above be cancelled. Consequently there is no need hereafter, to obtain licence under the Tamil Nadu District Municipalities Act, 1920, day according to the cinematograph films.
