The following emendments are issued to the Tamil Nadu Financial Code, Volume-I (Corrected upto 30th June 1980):-

Amendment Na.1/88

Page 178-Article 210.A(2):-

Add the following after the words "or mainly out of Covernment grants" in the fourth line on page 178.

> "The Register should be maintained by the grantee institutions separately in respect of each sanctioning authority".

Amendment No.2/88

Page 178-Article 210-A(2):-

Introduce the following as the 5th sub-pers in Article 210-A (2) on page 178.

"The sanctioning authorities should mainte'n Block accounts also, in Tamil Nadu Financial code, Form 36 of Permanent and Semi-permanent assets acquired wholly or mainly out of Government grants. This record should be of a permanent nature and should be posted from the annual returns furnished by the grantee institutions as required in the para mentioned above".

Amendment No.3/88

Page 178-Article 210-A(2):-

Introduce the following as the 6th Sub-para in Article 210-A(2) in page 178.

"Departments of Secretariat/Heads of Papertments sanctioning the grant, shall take up the matter with the grantee institutions if the annual returns are not received in time, so that they are in a position to maintain their own records complete as required under the rules".
