ORDER:

In the Government Orders first to sixth read above, orders have been issued specifying the portraits of leaders permitted by the Government for display in the Council/Meeting Hall and in other buildings belonging to Local Bodies in the State. The list contains two categories of portraits viz. (i) Obligatory and (ii) permissible portraits.

2. In the letter seventh read above, the Government have permitted the display of the portraits of the Ex-Chief Ministers and of the incumbent Chief Minister of the State, in Government office buildings.

3. The Government after careful consideration have decided to permit the display of the portraits of the Ex-Chief Ministers and the incumbent Chief Minister in the Council Hall/Meeting Hall and in other buildings belonging to the Corporation/Municipalities. Accordingly, they permit the display of the portraits of the Ex-Chief Minister and the incumbent Chief Minister in the Council Hall/Meeting Hall and in other buildings belonging to local bodies, viz., Municipalities, Municipal Township Committees and Corporations of Madras, Madurai and Coimbatore.

4. The following amendment is issued to G.O.Ms.No.1632, Rural Development and Local Administration, dated 7.10.1977, as subsequently amended.

AMENDMENT

In para 3 of the said Government Order under the category II "Permissible" the following entry may be added as item No.XII, namely:-

XII Ex-Chief Ministers and the incumbent Chief Minister.

5. The expenditure involved in the display of the portraits of the Ex-Chief Ministers and the incumbent Chief Minister shall be met from the Office contingencies of the respective local bodies.
