ORDER:

In the G.O.first read above, the Government published a notification inviting objections and suggestions on the proposals to constitute a Municipality (Third Grade) for the area within the jurisdiction of Usilampatti Town Panchayat (Selection Grade) in Madurai District. The Usilampatti Town Panchayat in its Resolution No.330, dt.22.10.1993, has resolved that the proposal to constitute the Usilampatti Town Panchayat into Municipality may be postponed for three years. After, careful examination, the Government overrule this objection and direct that a municipality (Third Grade) be constituted with effect from 11.12.95 for the Usilampatti Town Panchayat area.

2. Under Section 7(1) of the Tamil Nadu District Municipalities Act, 1920 (Tamil Nadu Act V of 1920) the total number of Councillors of the new Municipality will be fixed at twenty five.

3. Orders regarding the appointment of a Special Officer for the Municipality under section 368 of the Tamil Nadu District Municipalities Act, 1920 (Tamil Nadu Act V of 1920) will be issued separately.

4. Under section 4(5) of the Tamil Nadu District Municipalities Act, 1920 (Tamil Nadu Act V of 1920), the Government direct that the markets, fairs, Maternity and Child Welfare Centres and such other items or institutions, if any, which are under the jurisdiction and within the limits of the present Usilampatti Town Panchayat (Selection Grade) and which shall hereafter be statutorily maintained by the municipality according to the actual location, shall be transferred to the Usilampatti Municipality (Third Grade) with effect from the 11th December 1995 FN.

5. The following further orders are issued:-

- (1) The maintenance of the institutions transferred to new municipality and the payment of salaries of the staff, excluding teaching and non-teaching staff of schools, shall be met from the funds of the municipality. They will be eligible for the Government grants payable for the maintenance of educational institutions and Maternity Child Welfare Centres.
- (2) The Government also direct that the entire staff in the Town Panchayat (Except the Executive Officer) the Maternity and Child Welfare institutions as on 11.12.95 forenoon shall be transferred from the Town Panchayat Service to the Municipal Service with effect from the 11.12.95 FN.
- (3) The Collector of Madurai is requested to transfer the properties of the Usilampatti Town Panchayat with assets and liabilities to the Municipal Council to be constituted. If there are any difficulties on the actual transfer of assets and liabilities, the Collector should bring them to the notice of the Government.
- (4) The Commissioner of Municipal Administration is empowered to create necessary essential posts as per norms in addition to the posts now absorbed from the Town Panchayat service while Usilampatti Municipality (Third Grade) is constituted.
- (5) The Collector of Madurai is permitted to incur any expenditure which will be necessary for the inauguration of the new Municipality.
- (6) The Special Officer, Usilampatti Municipality is requested to address the Government in the Education Department for release of maintenance grant for educational institutions. His attention is also invited to section 34 of the Tamil Nadu Elementary Education Act, 1920 which empowers the Municipal Councils to levy Education tax with the prior concurrence of the Government. He is requested to send proposals to the Government in the Education Department for the levy of this tax.

6. The appended notification will be published in English in the Tamil Nadu Government Gazette Extra-ordinary dated the 11.12.95 and in Tamil in the Madurai District Gazette. The Director of Translation is requested to have the notifications translated into Tamil and forward the translations urgently to the Collector of Madurai District for publication in the District Gazette.

NOTIFICATION - II




