APPENDIX

NOTIFICATION - I.

In exercise of the powers conferred by section 363 of the Tamil Nadu District Municipalities Act, 1920 (Tamil Nadu Act V of 1920), the Governor of Tamil Nadu hereby authorises the Commissioner of Town Panchayats to exercise the powers under sub-sections (1), (2) and (3) of section 3-I of the said Act in respect of all the Town Panchayats in the State.

NOTIFICATION - II

In exercise of the powers conferred by section 363 of the Tamil Nadu District Municipalities Act, 1920 (Tamil Nadu Act V of 1920), the Governor of Tamil Nadu hereby authorises the Commissioner of Municipal Administration to exercise the powers vested with the Government under section 43 of the said Act in respect of all the Municipalities in the State.

NOTIFICATION - III

In exercise of the powers conferred by section 44-AA of the Madras City Municipal Corporation Act, 1919 (Tamil Nadu Act IV of 1919), the Governor of Tamil Nadu hereby authorises the Commissioner, Corporation of Madras, to exercise the powers vested with the Government under sub-sections (3), (4) and (5) of the Section 5 and section 45 of the said Act.

NOTIFICATION - IV

In exercise of the powers conferred by section 48-A of the Madurai City Municipal Corporation Act, 1971 (Tamil Nadu Act 15 of 1971), the Governor of Tamil Nadu hereby authorises the Commissioner, Corporation of Madurai, to exercise the powers vested with the Government under sub-sections (3), (4) and (5) of section 5 and section 49 of the said Act.

NOTIFICATION - V

In exercise of the powers conferred by section 50-A of the Coimbatore City Municipal Corporation Act, 1981 (Tamil Nadu Act 25 of 1981), the Governor of Tamil Nadu hereby authorises the Commissioner, Corporation of Coimbatore, to exercise the powers vested with the Government under sub-sections (3), (4) and (5) of section 5 and section 51 of the said Act.

NOTIFICATION - VI.

In exercise of the powers conferred by section 50-A of the Coimbatore City Municipal Corporation Act, 1931 (Tamil Nadu Act 25 of 1931) read with section 3 of the Tiruchirappalli City Municipal Corporation Act, 1994 (Tamil Nadu Act 27 of 1994), the Governor of Tamil Nadu hereby authorises the Commissioner, Corporation of Tiruchirappalli, to exercise the powers vested with the Government under sub-sections (3), (4) and (5) of section 5 of the said Tamil Nadu Act 27 of 1994 and section 51 of the said Tamil Nadu Act 25 of 1931 in respect of the Corporation of Tiruchirappalli,

NOTIFICATION - VII

In exercise of the powers conferred by section 50-A of the Coimbatore City Municipal Corporation Act, 1931 (Tamil Nadu Act 25 of 1931) read with section 3 of the Salem City Municipal Corporation Act, 1994 (Tamil Nadu Act 28 of 1994), the Governor of Tamil Nadu hereby authorises the Commissioner of Salem to exercise the powers vested with the Government under sub-sections (3), (4), and (5) of section 5 of the said Tamil Nadu Act 28 of 1994 and section 51 of the said Tamil Nadu Act 25 of 1931 in respect of the Corporation of Salem.

NOTIFICATION - VIII

In exercise of the powers conferred by section 50-A of the Coimbatore City Municipal Corporation Act, 1931 (Tamil Nadu Act 25 of 1931) read with section 3 of the Tirunelveli City Municipal Corporation Act, 1994 (Tamil Nadu Act 29 of 1994), the Governor of Tamil Nadu hereby authorises the Commissioner, Corporation of Tirunelveli, to exercise the powers vested with the Government under sub-section (3), (4) and (5) of section 5 of the said Tamil Nadu Act 29 of 1994 and section 51 of the said Tamil Nadu Act 25 of 1931 in respect of the Corporation of Tirunelveli.
